Table Covers

ERA or NEDA table covers are required. If you do not have one, contact Frances McGillis at the ERA Office, 949-551-5200. Table covers are \$85 for ERA members or \$115 for non-members. (Rush orders within three weeks of a show are \$20 extra.)

Promotion

Flyers will be sent to engineers and buyers in the show areas and exhibitors receive a supply of flyers for distribution to their accounts. Promotion will be done by mail and email. Exhibitors will also receive a show flyer PDF and are asked to send it to customers on their company email list.

Attendee List

After each show, exhibitors will receive a list of attendees with address, phone, fax, and email.

Lunch

A complimentary light lunch will be served from 11:00 to 2:00 for attendees and exhibitors.

Cost

ERA member cost per table, per show is \$195, or \$340 for a table in both shows.
